POLICY OF USE: *(Initials next to bottom two paragraphs are required)*

The use of the clubs.asua.arizona.edu server is a privilege granted to the recognized clubs and organizations at The University of Arizona. When using an account on the clubs.asua.arizona.edu server, you agree to:

1. Take no actions which violate the Student Code of Conduct, Classified Staff Personnel Policy Manual, University Handbook for Appointed Personnel or the University of Arizona Computing Policies.
2. Use the Club/Organization account for appropriate purposes only. Inappropriate use includes, but is not limited to:
 - Sending harassing messages or, in any way, harassing other computer users
 - Gaining OR attempting to gain, on any computer or network system, access to accounts or files without the owner's permission
 - Playing games
 - Advertising
 - Making unauthorized copies of any copyright-protected software, regardless of source
 - Taking action that threatens the security of the computer system, or that destroys or damages computer resources.
3. Use the account only for business of the Club/Organization the account is created for. The account is being created for the organization to provide a *basic* mean of communication between the Club/Organization and the University of Arizona community, and no personal business should be conducted through this account. Accounts that have not been renewed within a year of the expiration date will be deleted. The signers of this agreement are acting as representatives of the organization, and all files and contents of the account are owned by the organization, not the person(s) with access to the account.

Please read and initial the following:

_____ Yes, I have read, understood and agree with the above statements. If I do not agree, my Club/Organization account will not be enabled. Failure to abide by these policies will result in revocation of my Club/Organization privileges to use ASUA computing facilities. Although There are backup procedures in place, and since recoverability of data cannot be guaranteed, use of my account is at my risk. The Courts consider files, data and disks as UA property and, therefore, subject to subpoena. Although the amount of space allocated on the clubs.asua.arizona.edu server is 200MB per account, the server should not be used as storage medium for files that are not used actively by the club's website.
